ADVICE UNDER SECTION 48A(1)(a) ENVIRONMENTAL PROTECTION ACT 1986

Metropolitan Region Scheme Amendment 1300/57

Location: Wattle Grove

Determination: Scheme Not Assessed – Advice Given (no appeals)

Determination Published: 10 August 2015

Summary

The Western Australian Planning Commission (WAPC) proposes to rezone approximately 47.44 hectares of land in Wattle Grove from Rural to Industrial zone in the Metropolitan Region Scheme (MRS) as part of the Maddington Kenwick Strategic Employment Area (MKSEA).

The Environmental Protection Authority (EPA) has considered the scheme amendment in accordance with the requirements of the *Environmental Protection Act 1986* (EP Act). In making its decision on whether to assess the scheme amendment, the EPA has applied its 'Significance Framework' which relates to the extent to which the scheme amendment meets the EPA's environmental objectives for the environmental factors.

The EPA considers that the scheme amendment is unlikely to have a significant effect on the environment and does not warrant formal assessment under Part IV of the EP Act. The potential impacts from the scheme amendment can be adequately managed to meet the EPA's objectives through the implementation of the future local scheme provisions, management plans and regulated through other statutory processes.

1. Environmental Factors

The EPA has identified the following preliminary environmental factors relevant to this scheme amendment:

- a) Flora and vegetation; and
- b) Inland waters environmental quality.

2. Advice and Recommendations regarding Environmental Factors

The EPA has based its decision on the scheme amendment documentation provided by the WAPC. The EPA provides the following advice regarding potential impacts to the key environmental factors:

a. Flora and vegetation and Inland Waters Environmental Quality

The MKSEA amendment area contains significant key environmental values, most notably Bush Forever Site (BFS) 387 – the Greater Brixton Street Wetlands which contains values which are of state and national significance. Majority of BFS 387 is mapped as a Conservation Category Wetland (CCW). The MKSEA area also contains other CCWs and

the Guildford vegetation complex, which has only 5.9% remaining of its original extent. This is the lowest extent remaining of all vegetation complexes on the Swan Coastal Plain.

The EPA considers that any future development over this area will need to adequately retain, manage and protect these key environmental values. The EPA notes that an indicative local structure plan has been prepared over the area which proposes to retain the majority of the key environmental values. The EPA is in support of the indicative plan, but acknowledges that additional work is yet to be undertaken to finalise the plan.

The MRS amendment does not contain any scheme provisions to manage impacts to these values, which is consistent with most region scheme amendments. However, several mechanisms have been proposed by the Shire of Kalamunda to manage potential impacts, specifically through future local scheme amendments, and structure planning stages.

The EPA considers that the amendment could be managed to meet its environmental objectives, through the preparation of future local planning scheme provisions and structure plans to retain, manage and protect key environmental values.

Recommendation

The EPA concludes that the amendment can be managed to meet the EPA's environmental objectives, through the preparation of future local planning scheme provisions and structure plans to manage and protect key environmental values.

The EPA notes that the potential mechanisms proposed by the Shire of Kalamunda may not be consistent with WAPC policy. The EPA recommends that the Department of Planning liaise with the Shire of Kalamunda to develop appropriate mechanisms which can be included in the local scheme amendments.

The EPA also recommends that the Department of Planning liaise with the Shire of Kalamunda regarding the preparation of future structure plans, as they may need to be revised to be consistent with work undertaken for the Strategic Assessment of the Perth and Peel regions.
