## PLUTO LIQUEFIED NATURAL GAS DEVELOPMENT (SITE B OPTION) BURRUP PENINSULA, SHIRE OF ROEBOURNE

**Proposal:** The construction of facilities for the development of the

Pluto Gas Field on the North-West Shelf, and the

processing and export of the gas at a liquefied natural gas

plant to be constructed on the Burrup Peninsula.

The implementation of the proposal to which the above reports of the Environmental Protection Authority relate is subject to the conditions and procedures contained in Ministerial Statement No. 757, as amended by the following:

## 1. Conditions 6-12 to 6-14 replaced

Conditions 6-12, 6-13 and 6-14 of Ministerial Statement 757 are deleted and replaced with the following:

- "6-12 Within three months following completion of the marine works, the proponent shall repeat evaluation of the health of benthic communities, at the representative survey sites established by conditions 6-11(4) and 6-11(5), to the requirements of the Office of the Environmental Protection Authority.
- 6-13 The proponent shall repeat the survey required by condition 6-12, at the same time of year annually for three years, or for a lesser number of years as determined by the CEO of the Office of the Environmental Protection Authority, on advice of the Department of Environment and Conservation and the Department of Fisheries.
- 6-14 Within three months following completion of each of the surveys required by conditions 6-12 and 6-13, the proponent shall report the findings of each of the surveys to the Office of the Environmental Protection Authority and the Department of Environment and Conservation."
