**ROY HILL 1 IRON ORE PROJECT, PORT INFRASTRUCTURE  
PORT HEDLAND**

**Proposal:** The proposal is to construct and operate port infrastructure which includes a stockyard facility, rail loop, conveyor, wharf and ship-loading facility at Port Hedland.

## **7 Dewatering Discharge Management**

- 7-1 The proponent shall implement the Roy Hill Port Infrastructure Project – Port Hedland – Dewatering Outfall Management Plan (100RH-3000-EN-PLN-2006 Rev 2, 9 May 2014), or its revisions as accepted in writing by the \*CEO, when discharging dewatered groundwater to the marine environment.
