**STATEMENT TO AMEND CONDITIONS APPLYING TO A PROPOSAL
(PURSUANT TO THE PROVISIONS OF SECTION 46 OF THE
ENVIRONMENTAL PROTECTION ACT 1986)**

YELLOWFIN TUNA AQUACULTURE TRIAL,
ZEEWIJK CHANNEL, ABROLHOS ISLANDS

Proposal: The implementation of a three year, pilot scale Mulloway (*Argyrosomus hololepidotus*) and Yellowtail Kingfish (*Seriola lalandi*) seacage aquaculture trial in the Zeewijk Channel, Abrolhos Islands (approximately 75 Kilometres west of Geraldton), as documented in Schedule 1 of Ministerial Statement 649.

Condition 4 of Ministerial Statement 649, as inserted by Ministerial Statement 929, is deleted and replaced with:

4 Time Limit for Authorisation

- 4-1 The proponent shall not commence implementation of the proposal after 12 August 2017, and any commencement prior to this date must be substantial.
- 4-2 Any commencement of implementation of the proposal, prior to 12 August 2017, must be demonstrated as substantial by providing the Chief Executive Officer* with written evidence, on or before 12 August 2017.

* The Chief Executive Officer of the Department of the Public Service which is responsible for the administration of section 48 of the *Environmental Protection Act 1986*, or his delegate.
