I am writing to you on behalf of SITA Australia Pty Ltd with regards to advice received from your office on 18 July 2013 pertaining to the clearing of a small number of scattered trees on Lot 4869 in Certificate of Title Vol 285, Fol 78A, Great Southern Highway, Saint Ronans. The area in question falls under a Soil Conservation Notice (File 940930V03POB), which I have attached for your benefit. The clearing works are required in order to facilitate the widening of the access road for the proposed Allawuna Farm Landfill, and every effort has been made to design the road and its path in such a way as to minimise the number of trees that need to be

The advice we received from the office of the Commissioner on 18/7/2013 was that limited clearing for the widening of the site access road is acceptable and would not contravene the clearing restriction of the covenant.

Can you please confirm this? The remainder of the conservation covenant protected bushland will remain untouched.

Please find attached the relevant drawings indicating the path of the road and the trees that will need to be cleared. I have marked up one of the drawings to show the relevant part of the area that is covered by the soil conservation notice.

The proposed clearing was also referred to the Department of Sustainability, Environment, Water, Population and Communities (DSEWPaC) and identified as a not-controlled action with negligible potential for impact on federally-protected matters. Please find the DSEWPaC advice attached.
