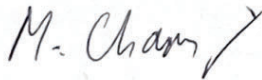

Marlinyu Ghoorlie people have been consulted by KCGM on the Fimiston South project over a number of years from 2021 to 2023. Additionally, Marlinyu Ghoorlie has been engaged to conduct cultural heritage surveys over the project area in 2022 and have provided reports to KCGM for consideration throughout delivery of the project to protect and manage Aboriginal cultural heritage. This includes KCGM engaging three Marlinyu Ghoorlie cultural monitors during all initial ground disturbance activity throughout the project, which KCGM is committed to.

In coming months, we look forward to working with KCGM to review the site's Aboriginal Cultural Heritage Management Plan (ACHMP). This review will ensure Aboriginal sites and their values within KCGM's operations are protected and managed. The ACHMP will continue to be reviewed by Marlinyu Ghoorlie with KCGM on an annual basis.

KCGM has demonstrated their commitment to work in partnership with the Marlinyu Ghoorlie people, and we look forward to continuing to grow our relationship throughout delivery of the Fimiston South project.

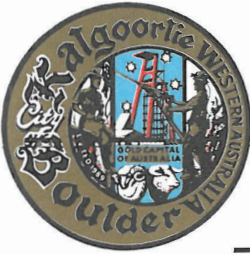

Re: Northern Star Resources Fimiston South Project

I am pleased to advise you of my support for Northern Star Resources' (Northern Star) Fimiston South Project. As Mayor of the City of Kalgoorlie-Boulder, I fully support what the Company calls its 'KCGM Operations', including the Fimiston Open Pit (Super Pit).

Northern Star has been a good neighbour to our community, and while there have been historical community concerns, they were all during the period of the previous owners of KCGM. This is because Northern Star is proactive in keeping our community fully informed, and their management follow through on commitments, such as sound environmental management of noise and dust.

Last month, General Manager of KCGM Operations Nick Strong addressed Council on Northern Star's growth plans for the Super Pit and extended lifespan of the mine, the biggest single employer in the Goldfields. He was forthright in the challenges they faced in working so close to the residential area, but outlined their mitigation plans and answered questions that were well-accepted by the Councillors.

Through understanding Northern Star's approach to mine planning and environmental impact management, the councillors have confidence that the Company's planned activities and mining practices will meet the approval of our community.

This mine is crucial to our community, and its expansion and extension of its lifespan gives us confidence for the future.

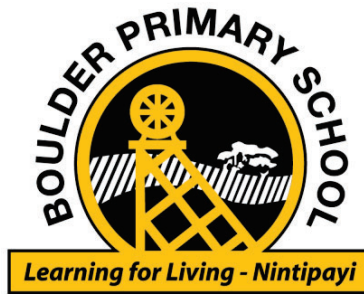
I support the Fimiston South growth project and will be pleased to answer any concerns your office may have about Northern Star's interaction with our community.

RE: Northern Star Resources Fimiston South Expansion Project

Voconiq is a data science and community engagement company built on a platform of technology and social science developed over a decade in Australia's national science agency, CSIRO. Voconiq uses surveys conducted periodically to bring the unfiltered voice of community into the companies that work alongside them to support stronger, more productive relationships. This service is called Local Voices.

In 2019, KCGM (via its then parent company Newmont) engaged Voconiq to deploy the Local Voices service in Kalgoorlie-Boulder. Fundamental to the deployment of Local Voices is the arms-length nature of the relationship between Voconiq and, in this case, KCGM, to derive social performance data and engage community directly. Northern Star Resources (NSR) have continued funding the Local Voices program in the communities of Kalgoorlie-Boulder, providing an important understanding of community perspectives about developments at the site over this time.

Since 2019, 2,165 community surveys have been collected and included in analysis of the relationship between NSR's KCGM site and Kalgoorlie-Boulder. The nature of Local Voices means that a comprehensive baseline survey was conducted in September 2019, followed by seven brief quarterly Pulse surveys to track changes over time and allow NSR to focus on specific issues of interest as they emerge. The Local Voices Kalgoorlie-Boulder project website may be accessed here: voconiqlocalvoices.com/kalgoorlie-boulder/.

Since the December 2020 Pulse survey, specific questions related to the Fimiston South project have been included in Pulse surveys, providing multiple time points of data on this topic. The included questions relate to the following topics:

- awareness of the project,
- acceptance of the project,
- perceived benefits and impacts related to the project,
- responsiveness of NSR to community concerns.

Summary of the data

Awareness of the Fimiston South Project

In December 2021 community members were asked to rate the extent to which they were aware of the KCGM Fimiston South Project on a 1 (Not at all aware) to 5 (Extremely aware) scale. Overall, awareness has increased from 2.86 on this scale to 3.14 between 12/21 and 03/22, with awareness increasing quickly between 07/21 and 03/22. Whilst awareness among KCGM employees has been consistently high over this time, awareness among non-employee community members has increased sharply since July 2021, from 2.15 to 3.02 for

near mine community members and 2.33 to 2.91 among community members living further from site.

Acceptance of the Fimiston South Project

New developments are always challenging for communities, particularly those living in close proximity to a large complex like KCGM. Overall acceptance of the Fimiston South Project has remained strong and relatively stable in the period between 12/20 (average score 3.66 on a scale from 1=Not at all to 5=Extremely) and 03/22 (average score 3.56).

For non-employee community members, acceptance has improved sharply among near mine neighbours since mid-2021, from 2.97 (07/21) to 3.36 (03/22). Among community members that live further from the mine, ratings of acceptance have remained steady over time (3.56 in 07/21 and 3.50 in 03/22).

Perceived impacts and benefits of the Fimiston South Project

Several questions or items have been included in Pulse surveys focused on expected Fimiston South Project impacts and benefits since these questions were included in Pulse surveys in April 2021.

Examining perceptions of future benefits first, there has been modest improvement in perceptions that the Project will lead to *“more investment by KCGM in the local community”*, with overall ratings improving from 3.56 in 04/21 (on a scale from 1=Strongly disagree to 5=Strongly agree) to 3.64 in 03/22. For near mine non-employee community members this has improved from 3.50 in 04/21 to 3.63 in 03/22, and community members further from the mine from 3.44 to 3.61 in the same period.

Similar modest improvements have been observed on perceptions that the Project will *“lead to more local employment”* in overall scores, with ratings increasing from 3.66 (04/21) to 3.76 (03/22). Among non-employee near mine community members these ratings were steady at 3.60 (04/21) and 3.61 (03/22), and improved markedly among community members further from the mine from 3.49 (04/21) to 3.79 (03/22).

This was also the case for ratings that the *“Fimiston South Project will lead to more opportunities for local businesses”*, with overall scores increasing from 3.62 to 3.70 between 04/21 and 03/22. Improvements on this measure increased more among near mine non-employee community members (from 3.49 to 3.64) and community members further from site (from 3.48 to 3.71) in this period.

Examining perceived impacts of activities related to the mine, which include activities related to the Fimiston South Project, Voconiq asked community members to rate their level of agreement that *“Taken together, the dust, noise and vibration impacts on the community are acceptable”* on a 1 (Strongly disagree) to 5 (Strongly agree) scale. Overall, ratings on this measure declined modestly between 12/20 (3.46) and 03/22 (3.32).

For near mine non-employee community members, these ratings moved from 3.11 to 3.05 in this period, and for community members further from the mine ratings were 3.49 in 12/20 and 3.48 in 03/22.

It is useful to note that for all of these items related to the Fimiston South Project, ratings were at or above the midpoint of the scales used (i.e. ratings were in positive territory).

NSR responsiveness

Finally, Voconiq measured how responsive community members felt that NSR is to community concerns. Specifically, participants were asked to rate their level of agreement that *"The company has been responsive to community concerns over the last 3 months"* on a scale from 1 (Strong disagree) to 5 (Strongly agree). Participants have been asked to respond to this item each quarter since April 2020.

Overall, community sentiment has declined slightly on this measure over time, from 3.31 in 04/20 to 3.18 in 03/22. For near mine, non-employee community members these ratings have remained positive and steady over time (3.15 in 04/20 and 3.13 in 03/22), as declined slightly for community members further from the mine (3.25 in 04/20 and 3.17 on 03/22).

In summary, the community sentiment data collected through the Voconiq Local Voices program in Kalgoorlie-Boulder indicates that:

- awareness of the Project has increased, in particular from mid-2021,
- acceptance of the project has remained strong and stable over time in the community overall, but has increased sharply among near neighbours to the mine since mid-2021,
- perceived future benefits as a result of the Project (increased community investment by NSR, local jobs, and opportunities for local businesses) have increased over time among most community members surveyed,
- ratings of acceptability of dust, noise and vibration impacts from the mine have either remained stable or declined slightly among community members since April 2020 in the context of significantly greater site activity.

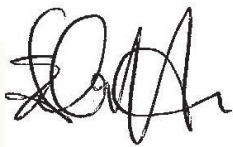

RE: APPLICATION TO WA ENVIRONMENTAL PROTECTION AUTHORITY

I write in support of the application being submitted by Northern Star Resources for their growth project, KCGM Operations 'Fimiston South'.

Northern Star Resources is a residential mine site with over 1,100 employees and contractors and is committed to supporting the community and, where possible, gives preference to locally owned and operated businesses.
