The forum attendee was concerned that the facility might be removed and not replaced.  <b>A:</b> Consideration for work on the skate park at Kambalda East. Photos of the skate park structures were provided by the attendee.</p> <p><b>Q:</b> The start time for the forum (1800hrs) is not really suitable for the industry given that people working in the industry who otherwise might want to attend are unable to as they do not finish work until 1800hrs.  <b>A:</b> SIGMC responded that consideration would be given to a later start time for the next forum. 1900hrs was suggested.</p>

				<p><b>Q:</b> How close is Pistol Club to Kambalda and has it been approved?  <b>A:</b> The forum member was not explicit about the reason for the query but there appeared to be two issues behind it. The first being that the forum member was looking for an opportunity to provide feedback on Pistol Club and was unaware that the project was approved and proceeding. The second implicit concern was around noise and dust. SIGMC confirmed that the Project had been approved by the EPA and DMIRS and was proceeding as an open cut operation and had some specific measures in place to address noise and dust.</p> <p><b>Q:</b> Why do you need a manual licence to be considered for work on the dump trucks (automatic) at the mine? Forum attendee gave example of daughter attending the jobs forum and being told that without a manual drivers licence she would not be considered.
