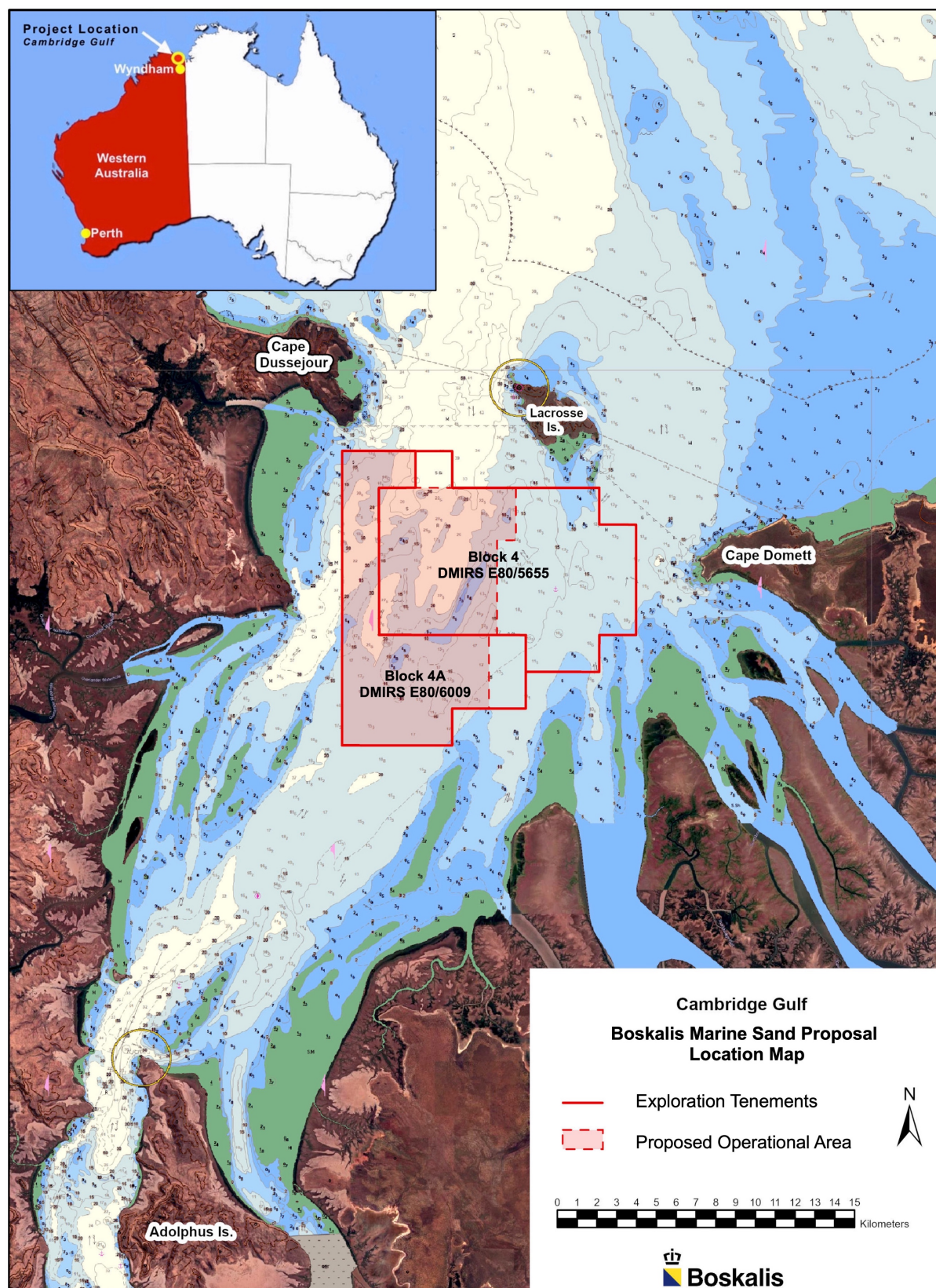


FIGURE 1: Location of the proposed project in Cambridge Gulf near Wyndham in the northeast of Western Australia.

EXECUTIVE SUMMARY

1. Boskalis Australia Pty Ltd (BKA) is currently assessing the feasibility of developing a marine sand-sourcing operation in Cambridge Gulf (CG) near the Port of Wyndham in the northeast of Western Australia (WA) (Figure 1). Despite the low likelihood of significant environmental impacts, as a responsible company with stringent environmental and social policies, BKA has committed to self-referring the proposal to the WA Environmental Protection Authority (WA EPA) under section 38 of the EP Act, and to the Commonwealth Department of Climate Change, Energy, the Environment & Water (DCCEW) under Part 7 of the EPBC Act, for their determination of what further environmental assessments might be required, if any.
2. BKA recognises that social licence is as important as regulatory licence for development proposals, and in order to ensure that the views, perspectives and positions of relevant key stakeholders are identified and addressed, since mid-2022 BKA has undertaken direct, in-person consultations with a wide range of key stakeholders.
3. This report presents details and outcomes of BKA's consultation program and outcomes to August 2024 (noting that BKA sees consultation as an ongoing process, including should the proposal go ahead).
4. The report includes a Stakeholder Analysis, which identified 26 key stakeholder organizations and eight key individuals (regional marine users).
5. Formal consultations with stakeholders were commenced in October 2022 and since then BKA implemented an ongoing program to consult with the key stakeholders as identified by the Stakeholder Analysis. In summary the major points to date include, *inter alia*:
 - a) Traditional Owners: The two Traditional Owner groups in the area (BAC and MG Corp) support the proposal so long as they are fully and closely consulted and it does not impact negatively on their interests, including Native Title and Aboriginal cultural heritage. BKA's studies and reports address potential risks to indigenous values and interests thoroughly – and no negative impacts are predicted. Both groups are working with BKA to develop MoUs, which include benefits sharing packages, and both groups have issued letters of support for the proposal as contained in Annexes to Referral Report No. 3 - Traditional Owner Matters (BKA 2024c).
 - b) Other support for the proposal: Several stakeholders consulted expressed support for the proposal so long as due process is followed and it does not cause significant negative impacts, including SWEK, KDC, KPA and CGL.
 - c) No objections to the proposal: While not stating explicit support for the proposal, several stakeholders stated that they have no objections in terms of their mandates or interests, including WA DoT-Maritime, Recfishwest and Wyndham-based commercial fisherman.
 - d) Marine biodiversity: Several stakeholders including WA DWER, DBCA, DPIRD Fisheries, the Commonwealth DCCEW and the Northern Prawn Fishery Industry identified potential impacts on inshore dolphin species, marine turtles, sawfish and river sharks as issues that needs to be addressed. BKA's studies and reports address potential risks to these species thoroughly – and significant impacts are not predicted (see Referral Report No. 4). If the proposal proceeds, BKA will look to support research and monitoring of relevant biodiversity issues in the CG area, in coordination with relevant biodiversity stakeholders.
 - e) Marine biosecurity: WA DWER and Commonwealth DCCEW identified the potential introduction of marine pests via ballast water and hull fouling as a main issue that needs to be addressed. BKA's studies and reports address potential risks to these species thoroughly – and no significant risks are predicted. The SPV will be fitted with IMO-compliant ballast water treatment system, and will comply with the Biofouling Regulation under the Commonwealth Biosecurity Act, including having an approved Biofouling Management Plan with very stringent biofouling prevention, management, mitigation and monitoring measures (see Referral Report No. 4).
 - f) Turbidity: WA DWER stated that while natural turbidity levels might be high in CG, potential turbidity impacts of the operation will still need to be thoroughly addressed, as per the WA EPA EIA guidelines – this should include the cumulative impacts of any additional turbidity caused by the operation over and above natural background levels. BKA's studies and reports address the turbidity issue thoroughly – and significant impacts are not predicted (see Referral Report No. 4).
 - g) Underwater noise: WA DWER stated that potential impacts of underwater noise from the SPV is a key issue that needs to be addressed (see Referral Report No. 4).
 - h) Commercial fisheries: Several stakeholder groups, including DPIRD Fisheries, AFMA, WAFIC and NPF Industry are interested to ensure that the proposal does not cause negative impacts on fisheries resources, commercial fisheries and fish species, including the gillnet fishery (mainly barramundi and threadfin salmon), the mud-crab fishery and the Northern Prawn Fishery (NPF). While there is an extremely low level of commercial fishing activity in CG (one gillnet operator only – who also fishes elsewhere along the coast outside of CG), fisheries stakeholders

highlighted the need to consider the potential role of CG as a nursery area. BKA's studies and reports address potential risks to fish and fisheries – and no significant impacts are predicted (see Referral Report No. 4). If the proposal proceeds, BKA will look to support research and monitoring of relevant fisheries issues in the CG area, in close coordination with relevant fisheries stakeholders.

- i) Recreational fisheries Issues: No objections to the proposal were raised by this sector as recreational fishing in the general area targets upstream and coastal areas and does not overlap with the proposed operational area. The proposal is unlikely to have negative impacts on recreational fishing (see Referral Report No. 4). Should the proposal be approved and proceed to operational phase, BKA will consider sponsoring WVMR, which will have safety benefits for the recreational fishing sector.
- j) Port, navigation & maritime issues: The WA DoT Maritime, KPA and CGL did not raise concerns about potential impacts on safety of navigation and port operations and KPA and CGL welcomed benefits for the Port of Wyndham (see Referral Report No. 4).
- k) Broader socioeconomic & community development: The EKCCI, KDC and SWEK support the project so long as there are no negative impacts and there are benefits for local socioeconomics, business and the community and for the shire and region overall. The proposal will have positive socioeconomic, business and the community impacts (see Referral Report No. 4). BKA will continue to keep these bodies informed and seek to work with them to optimize benefits.
- l) Environmental NGOs: The CCWA made two major points, 1) does BKA intend to self-refer the proposal to the State under the WA EP Act and Commonwealth EPBC Act?, and 2) are there marine nursery areas in CG that need to be protected? BKA is self-referring the proposal under the EP Act and EPBC Act. BKA recognizes that all of the mangrove and estuarine inlets around CG have nursery values, and has assessed this issue thoroughly. The proposal will not impact directly or indirectly on these areas (see Referral Report No. 4). Environs Kimberley, an NGO based in Broome, did not respond to consultation invitations via email and phone.

1. BACKGROUND & PURPOSE OF THIS REPORT

1. Boskalis Australia Pty Ltd (BKA) is currently assessing the feasibility of developing a marine sand-sourcing operation in Cambridge Gulf (CG) near the Port of Wyndham in the northeast of Western Australia (WA) (Map 1). The sand in CG is derived from natural terrestrial sources in the catchment, supplied via river inputs. The sand would be exported to Asian markets for use in construction projects. A more detailed description of the proposed operation is presented in the *Proposal Content Document* (PCD) and more detailed descriptions of the location, context and the environment of the area are presented in Referral Report No. 2 - Proposal Setting & Existing Environment Descriptions (BKA 2024b).
2. To support its feasibility assessment BKA has undertaken a wide range of environmental, engineering, economic and other studies since early 2022. These studies find that the proposal is feasible and viable and unlikely to cause significant environmental impacts, as defined under the WA *Environmental Protection Act* (EP Act), the Commonwealth *Environmental Protection & Biodiversity Conservation Act* (EPBC Act) and other relevant State and Commonwealth legislation. The findings of these studies are presented in Referral Report No. 4.
3. Never-the-less, despite the low likelihood of significant environmental impacts, as a responsible company with stringent environmental, social, sustainability and governance policies, BKA has committed to self-referring the proposal to the WA Environmental Protection Authority (WA EPA) under section 38 of the EP Act, and to the Commonwealth Department of Climate Change, Energy, the Environment & Water (DCCEW) under Part 7 of the EPBC Act, for their determination of what further environmental assessments might be required, if any. If it is determined that assessment is required under both Acts, BKA will seek a joint process under the WA environmental assessment system, which is accredited by the Commonwealth.
4. As part of this process, recognising that social licence is as important as regulatory licence for such projects, in order to ensure that the views, perspectives and positions of relevant key stakeholders are identified and addressed, since mid-2022 BKA has undertaken direct, in-person consultations with a wide range of key stakeholders.
5. The purpose of this report is to present the outcomes of the pre-referral consultation process, in support of BKA's self-referral under the WA EP Act. A version of this report will also be submitted to DCCEW in support of BKA's self-referral under the Commonwealth EPBC Act.
6. This report is not seen by BKA as the end of the consultation process. On-going stakeholder engagement is planned, as outlined in section 3.

2. STAKEHOLDER ANALYSIS

1. Stakeholder engagement and consultation cannot be carried out without first developing a stakeholder analysis, to identify the key stakeholders and what their respective mandates, roles and interests might be in relation to the proposal. The stakeholder analysis identified 26 key stakeholder organizations as presented in Table 1 and listed below (in alphabetical order under each category):

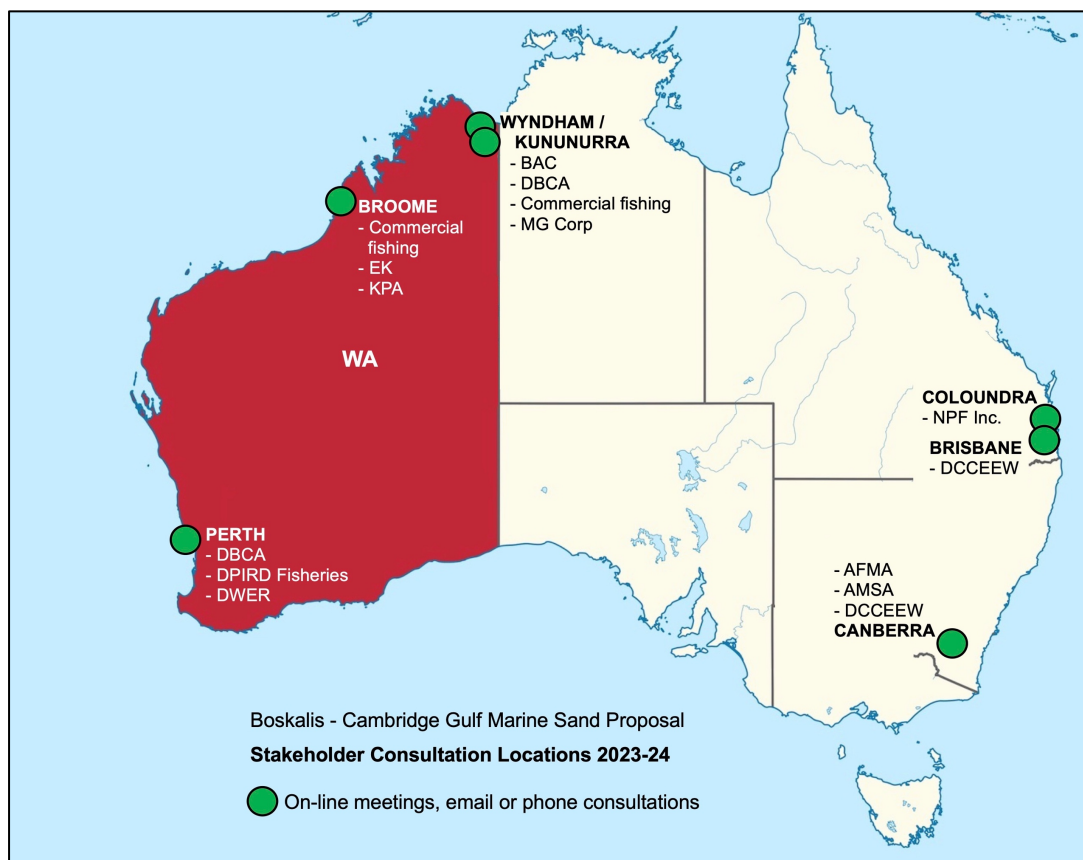
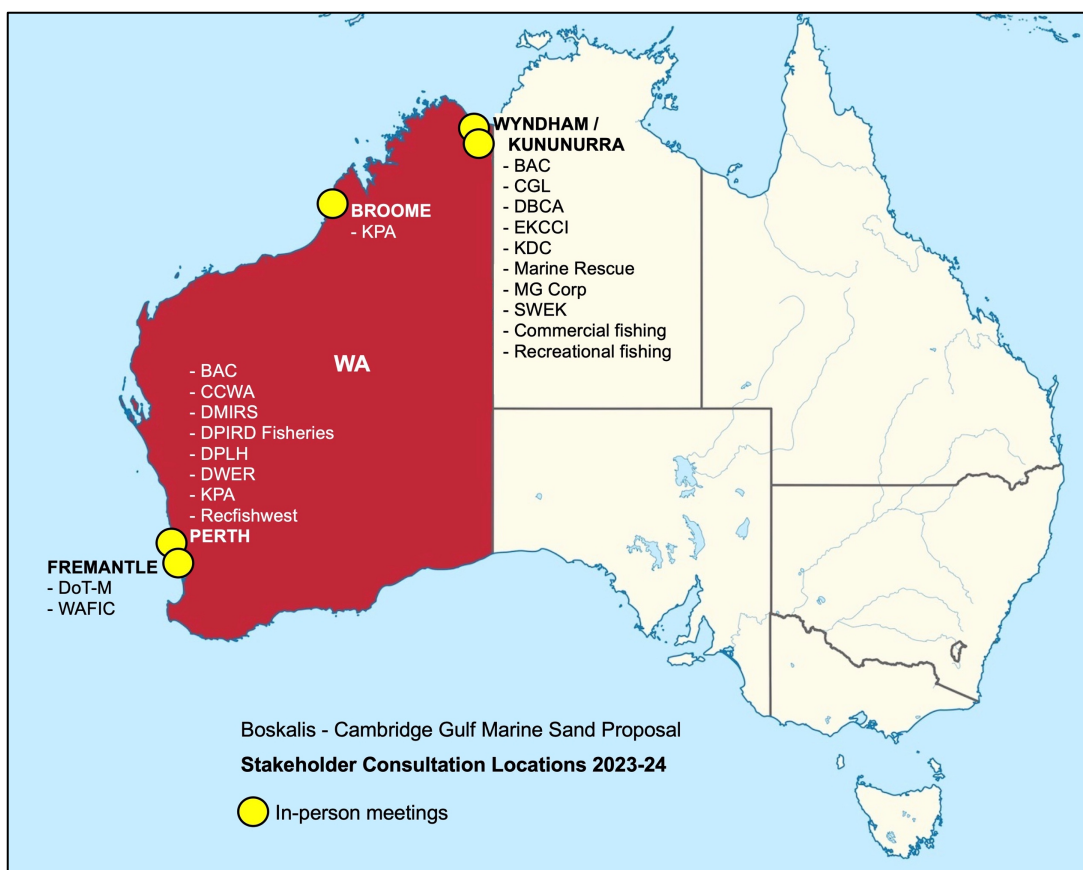
3. CONSULTATION ACTIVITIES TO DATE

1. Formal consultations with stakeholders were commenced in October 2022 and since then BKA has implemented an ongoing program to consult with most of the key stakeholders identified by the Stakeholder Analysis presented in section 3 above.
2. Consultations have been held via both in-person meetings and on-line meetings using Teams or Zoom. Table 3 lists the in-person and on-line meetings held between the beginning of October 2022 and the end of May 2024, on a month-by-month basis. There were also email and phone consultations with many of the stakeholders throughout this period, which are not shown.
3. Figure 2 shows that in-person meetings have been held with stakeholders in Perth, Fremantle, Broome, Wyndham and Kununurra. Figure 3 shows that on-line or phone meetings have been held with stakeholders located in Perth, Broome, Brisbane, Coloundra, Canberra, Wyndham and Kununurra.
4. Table 4 lists each in-person and on-line meeting that has been held between the beginning of October 2022 and the end of May 2024, in reverse chronological order (from the latest meeting), and lists the participants in each meeting. Table 4 show that during this period BKA has engaged in 34 separate meetings with 23 different key stakeholders, either in-person or on-line.
5. As shown in Tables 1, 3 and 4 some stakeholders have been met with more than once, these being BAC (four meetings - one postponed), MG Corp (three meetings - one postponed), DBCA (two meetings), DPIRD Fisheries (four meetings), DWER (two meetings), KDC (two meetings), KPA (two meetings), SWEK (two meetings), DCCEEW (two meetings) and local commercial fisherman Mark Douglas (three meetings).
6. In addition to the 34 separate meetings there have also been on-going phone calls and emails between BKA and some stakeholders, reporting progress or following-up on items discussed in meetings.
7. As shown in Tables 1 and 4 some stakeholders have not been directly consulted to date, these being DPIRD-RDD (consulted via KDC), WA EPA (as comms are via DWER), AHO (not relevant at this stage – will be advised of charting implications if proposal progresses), DAFF (regulatory requirements are clear), Parks Australia (proposal will not impact on Commonwealth Marine Park), EK (did not respond to phone and email meeting invitations), four commercial fishermen (one does not wish to be consulted as selling licence and three did not respond to meeting invitations) and one recreational fishing tour operator in Wyndham (could not be contacted).
8. As outlined in section 5, the consultation activities undertaken to the end of May 2024 are not seen by BKA as the end of the consultation process and on-going stakeholder engagement is planned

4. CONSULTATION OUTCOMES – MAIN ISSUES RAISED

1. Table 5 summarizes the issues and points raised by each stakeholder that has been consulted to date, along with BKA's response to each issue and point.
2. Records of each consultation meeting held up to end of May 2024 are kept on file and can be provided if required. All meeting minutes were provided in draft form to the meeting participants for review and comment before being finalized.
3. In addition to issues raised during meetings, as recorded, some stakeholders also emailed additional comments and inputs to BKA after the meetings – and these are reflected in the analysis.
4. An analysis of all consultation outcomes to date identifies the following major points. Please refer Table 5 for more details.
 - a) Traditional Owners: The two Traditional Owner groups in the area (BAC and MG Corp) support the proposal so long as they are fully and closely consulted and it does not impact negatively on their interests, including Native Title and Aboriginal cultural heritage. BKA's studies and reports address potential risks to indigenous values and interests extremely thoroughly – and no negative impacts are predicted (refer Referral Report No. 3). Both groups are working with BKA to develop MoUs, which include benefits sharing packages, and both groups have issued letters of support for the proposal as attached to Referral Report No. 3.
 - b) Marine biodiversity (State): The WA DBCA seeks to ensure that the proposal does not cause significant impacts on protected areas under the WA *Conservation & Land Management Act* (CALM Act) and protected species under the WA *Biodiversity Conservation Act* (BD Act), including but not limited to the North Kimberley State Marine Park, marine turtle species and especially the Flatback Turtle nesting beach at Cape Domett, snubfin, humpback and other dolphin species and sawfish and river sharks. BKA's studies and reports address potential risks to marine biodiversity thoroughly – No significant impacts are predicted (see Referral Report No. 4). If the proposal proceeds, BKA will look to support research and monitoring of relevant marine biodiversity issues in the CG area, in close coordination with DBCA and Commonwealth DCCEEW.
 - c) Regulation under State Mining Act: The WA DMIRS seeks to ensure that the proposal complies in full with the WA *Mining Act*, including but not limited to the comprehensive environmental assessment and management provisions of that Act. BKA will address all requirements of the WA Mining Act thoroughly, including the environmental assessment and management provisions of the Act.
 - d) State environment department: The WA DWER provided clear advice to BKA on the process that needs to be followed in referring the proposal under section 38 of the EP Act, the various EIA guidelines that should be followed and the key issues that should be addressed. DWER recommended that BKA engage independent expert review of its hydrodynamics and coastal process studies and submit the reviews with the referral. In the 2nd pre-referral meeting

held in May 2024 DWER emphasised that BKA should give particular attention to addressing the following issues in its referral reports:

- Present the maximum case operational scenario.
- Consider temporal restrictions on operations during critical periods of marine turtle seasons.
- Potential lighting impacts of the SPV including on marine turtles will need to be addressed.
- Potential impact of underwater noise from the SPV is a key issue that needs to be addressed.
- While natural turbidity levels might be high in CG, potential turbidity impacts of the operation will still need to be thoroughly addressed, as per the WA EPA EIA guidelines.
- Marine biosecurity (potential introduction of marine pests via ballast water and hull fouling) will be a key issue.
- Some sampling techniques such as eDNA can be subject to sampling efficiency constraints, especially in a highly dynamic environment such as CG.

BKA's studies and reports address all relevant DWER and EPA requirements and guidelines thoroughly – No significant impacts are predicted (see Referral Report No.s 4 & 5).

- e) Commercial fisheries Issues: Several stakeholder groups, including DPIRD Fisheries, AFMA, WAFIC and NPF Industry are interested to ensure that the proposal does not cause negative impacts on fisheries resources, commercial fisheries and fish species, including the gillnet fishery (mainly barramundi and threadfin salmon), the mud-crab fishery, the Northern Prawn Fishery (NPF) and protected species such as sawfish and river sharks. While there is an extremely low level of commercial fishing activity in CG (one gillnet operator only – who also fishes elsewhere along the coast outside of CG), fisheries stakeholders highlighted the need to consider the potential role of CG as a nursery area.

BKA's studies and reports address potential risks to fish and fisheries thoroughly – and no significant impacts are predicted (see Referral Report No. 4). If the proposal proceeds, BKA will look to support research and monitoring of relevant fisheries issues in the CG area, in close coordination with all relevant fisheries stakeholders.

- f) Recreational fisheries Issues: No objections to the proposal were raised by this sector as recreational fishing in the general area targets upstream and coastal areas and does not overlap with the proposed operational area. The proposal is unlikely to have negative impacts on recreational fishing (see Referral Report No. 4). Should the proposal be approved and proceed to operational phase, BKA will consider sponsoring WVMR, which will have safety benefits for the recreational fishing sector.
- g) Port navigation & maritime issues: The WA DoT Maritime, KPA and CGL support the project so long as there are no negative impacts on safety of navigation and port operations and there are benefits for the Port of Wyndham. The proposal will not have negative impacts on port operations and there will be benefits for the port (see Referral Report No. 4).
- h) Broader socioeconomic & community development: The EKCCI, KDC and SWEK support the project so long as there are no negative impacts and there are benefits for local socioeconomics, business and the community and for the shire and region overall. The proposal will have positive socioeconomic, business and the community impacts (see Referral Report No. 4). BKA will continue to keep these bodies informed and seek to work with them to optimize benefits.
- i) Environmental NGOs: The CCWA made four major points:
- Does BKA intend to self-refer the proposal to the State under the WA EP Act and Commonwealth EPBC Act)?.
 - Are there marine nursery areas in CG that need to be protected?
 - In consulting with TOs it is important to account for seasonal factors – e.g. restricted mobility in wet season.
 - BKA should also consult with Broome-based NGO Environs Kimberly (EK).

BKA will self-refer the proposal under the EP Act and EPBC Act – this Stakeholder Consultation Report is part of the referral documentation. BKA recognizes that all of the mangrove and estuarine inlets around CG have nursery values, and has assessed this issue thoroughly. The proposal will not impact directly or indirectly on these areas (see Referral Report No. 4). BKA is consulting with TOs in accordance with their preferences. BKA has reached out to EK.
